REQUEST UNDER THE OFFICIAL INFORMATION ACT 1982

Thank you for your request dated **16 January 2016** made pursuant to the Official Information Act 1982 ("OIA").

Your Request

You have requested the following information:

- a list of all payments to communication, lobbying, government relations and media monitoring service providers, the date and amount of each, and what each payment relates to, for the period of 1 January 2014 to 31 December 2016. Please ensure all payments to Senate Communications are included.

In email and phone communications with you 17-19 January, you clarified that:

- your definition of communications includes (as well as general public relations/media/government relations activity) websites, videos, design work, publications (e.g. Annual Reports), sponsorship and events;
- payments relating to the preparation of submissions on regulatory/legislative policy matters are to be included;
- you are comfortable for us to exclude payments relating to our hosting of the 8th Annual Meeting of the International Forum of Sovereign Wealth Funds in 2016. This event was managed by our in-house team without PR or event consultancy support. Supplier payments included venue hire, catering, AV, programme production, security and logistics. All media and government relations activity was undertaken by Guardians staff. We also note that the costs of the meeting were largely defrayed through commercial partnerships and registration fees, with attendees paying for their own flights and accommodation. We have also excluded payments relating to other peer fund events which we have hosted at our offices. We did not engage communications/government relations firms to assist us with these events.

Details of the information we have pertaining to your request, and our response in respect of that request, are set out in the table **enclosed** at Appendix 1 to this letter.

As flagged to you in our email of 18 January, we have not disclosed payments for legal advice relating to changes to the New Zealand Superannuation and Retirement Income Act in 2015. Russell McVeagh provided advice to us in relation to our submissions on the Amendment Bill, but did not directly engage with The Treasury. We do not consider these

payments to be captured by a definition of lobbying or government relations, but mention them here for completeness.

We have also excluded payments for photography where these were paid directly to the photographer and not via a design or PR firm.

Background

The New Zealand Superannuation Fund is a global investment fund in which there is strong media and stakeholder interest, both in New Zealand and offshore. The Guardians has a small in-house team managing communications on behalf of the Fund in New Zealand and internationally (approximately 85% of the Fund is invested offshore). We utilise external suppliers to assist in workflow peaks, provide vacancy and annual leave cover, help manage media enquiries across time-zones, and to provide specialist advice and support when needed.

Regular Parliamentary Select Committee Reviews of the Guardians involve extensive disclosures regarding our expenditure on external suppliers, including public relations providers. Our Review responses also include a list of non-government organisations, associations and bodies the Guardians is a paid member of, and associated fees. Some of these groups make submissions on regulatory and public policy matters from time to time. Our response to the 2015/16 review by the Finance and Expenditure Select Committee is currently awaiting tabling in Parliament and is therefore confidential, but we expect will be published in early February.

Explanatory notes:

- Our main communications agencies are Insight Creative (design, web and print) and SweeneyVesty (communications). Neither undertakes Government relations work on our behalf.
- The timeframe of this request captures one-off costs relating to the redevelopment of the www.nzsuperfund.co.nz website and the development of a template for an online annual report microsite.
- The scope of our media monitoring activity includes media coverage of the Guardians and the Fund, selected investee companies, potential Fund investments and business sectors/topics of interest to our investment professionals, both in New Zealand and internationally.
- Your request included specific reference to Senate. In the interest of complete transparency, we note that SenateSHJ undertook crisis communications planning work for Kaingaroa Timberlands Partnership in 2014/15. The NZ Super Fund is a minority investor in Kaingaroa Timberlands and was involved the process to select an agency for this work; however, costs were paid by the Partnership and are therefore not included here.
- Similarly, Baldwin Boyle assisted Z Energy in its IPO in 2013. The NZ Super Fund was a 50% owner of Z Energy at the time and was involved in the process to select an agency for this work; however, costs were paid by Z Energy and are therefore not included here.
- Where payment to a supplier has been made in advance, the expense disclosed in our response relates to the services received in the period under review (i.e. if a supplier was paid in 2013 for services provided in 2014, these will still be disclosed in our response).

Our Response

Our response can be found at Appendix I.

We have withheld some information in order to maintain confidentiality and prevent commercial prejudice to our suppliers. As noted in Appendix I, costs for two pieces of stakeholder research undertaken for the Guardians by Colmar Brunton have been withheld under sections 9(2)(b)(i) and 9(2)(b)(ii) of the OIA. Colmar Brunton is a commercial entity operating in a highly competitive market. We note that reports on the stakeholder research projects Colmar Brunton undertook on our behalf are available on our website at <https://www.nzsuperfund.co.nz/stakeholderresearch>. Given that these reports include full details of the research methodology used, the costs charged provide non-public information about Colmar Brunton's pricing structure that is commercially sensitive to Colmar Brunton, and Colmar Brunton's commercial activities would be prejudiced by its release. We are concerned that they and other suppliers will not work with us in future if we cannot uphold the confidentiality of this information. We have considered whether the public interest in favour of disclosing this information outweighs our reasons for withholding it, and have concluded that it does not. It is in the public interest that we maintain the highest standards of commercial sensitivity and confidentiality with those we work with.
